#### **SHED ARHITECTURAL STANDARDS**

- 1. Maximum size is 200 sq. ft. Structures that exceed 200 sq. ft, are considered a "Detached Accessory Structure" which requires an alternative permit application.
- 2. No homeowner is permitted to have more than 1 (shed) structure on a single lot.
- 3. Structure may be site built or prefabricated.
- 4. Structure must be placed on a concrete pad or aggregate stone base.
- 5. Maximum roof pitch is 5/12 and cannot exceed 12 feet from the ground.
- 6. Unit must include an overhang on a minimum of 2 sides. (i.e., Front & Rear or, 2 Opposite sides).
- 7. Roofing finish must be one of the following materials: Wood shake shingles, tile, slate, cooper, non-reflective metal, asphalt, or fiberglass shingles.
- 8. Allowable roof styles include a gable roof, hip roof or shed roof.
- 9. Exterior siding must be one or a combination of any of the following: Vinyl siding, composite siding, stone veneer, wood shake, metal siding or sawn wood. Coloration of siding and roofing materials must be best match to existing house or complimentary in color.
- 10. Sheds shall be only a one-story structure. No living facilities, including plumbing, sleeping quarters or other habitable use shall be permitted.
- 11. Primary use is for the storage of lawn care equipment.
- 12. Shed location must be 10 feet from side yard property lines, 25 feet from front yard property line, 20 feet from rear yard property line (50 feet if lake front lot).
- 13. No rubbermade, plastic, canvas or metal structures are permitted.

Any contractor or homeowner starting construction prior to a permit being approved and issued will be subject to pay a \$100.00 penalty in addition to the published permit fee.

#### **INSPECTION AND PERMIT PROCESS REQUIREMENTS**

- a. Application must include "proof of ownership" of the property.
- b. A sight plan that identifies all lot boundaries and location of all existing and proposed structure.
- c. Contractor/Homeowners must mark out property line locations for pre-construction inspection by the Village Zoning Department.
- d. Upon the Zoning official's approval of the site inspection permit shall be issued and the fence may be installed.
- e. Zoning Permit posted in plain sight prior to start of construction.
- f. Identify fence height with complete description of all the proposed fence materials, screening plan if chain link as required above.
- g. The homeowner is responsible for making sure all contractors working on this project are registered with the Village prior to start of construction and/or installation.
- h. Once completed the Contractor/Homeowner must contact the Zoning Department for final inspection.
- i. HOA approval, if required.
- j. Installation of 3" reflective address sign must be installed in plain sight from street on primary structure and from lake, on lake front lots.
