

RESOLUTION NO. 837-07-2022

A RESOLUTION FOR THE SUBMISSION TO THE ELECTORS OF THE VILLAGE OF ROAMING SHORES, ASHTABULA COUNTY, OHIO, ON THE 8TH DAY OF NOVEMBER, 2022, OF THE QUESTION OF REPLACING AN EXISTING 4 MILL TAX LEVY AND AN INCREASE OF 1.0 MILLS TO CONSTITUTE A CONTINUOUS TAX OF 5.0 MILLS BEGINNING TAX YEAR 2023 FOR THE PURPOSES OF PROVIDING AND MAINTAINING MOTOR VEHICLES, COMMUNICATIONS, OTHER EQUIPMENT, BUILDINGS, AND SITES FOR BUILDINGS USED DIRECTLY IN THE OPERATION OF THE POLICE DEPARTMENT, OR THE PAYMENT OF SALARIES OF PERMANENT OR PART TIME POLICE, COMMUNICATIONS OR ADMINISTRATIVE PERSONNEL TO OPERATE THE SAME, INCLUDING THE PAYMENT OF ANY EMPLOYER CONTRIBUTIONS REQUIRED FOR SUCH PERSONNEL IN ACCORDANCE WITH R.C. 5705.19 (J) OF THE OHIO REVISED CODE WHEREAS SAID LEVY SHALL APPEAR UPON THE TAX DUPLICATE OF SAID VILLAGE OF ROAMING SHORES, ASHTABULA COUNTY, OHIO, FOR A CONTINUOUS NUMBER OF YEARS BEGINNING IN THE TAX YEAR 2023 AND DECLARING THIS RESOLUTION TO BE AN EMERGENCY MEASURE.

WHEREAS, the amount of taxes which may be raised within the 10 Mill Limitation will be insufficient to pay the current expenses of the Village of Roaming Shores for a continuous number of years.

WHEREAS, it is necessary to levy taxes in excess of said limitation for the purpose of providing a full time police department for such period of time.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Roaming Shores, Ashtabula County, Ohio, two-thirds (2/3) of all Council members elected thereto concurring:

SECTION 1. That in accordance with Sections 5705.19(J) and 5705.192 of the Revised Code of Ohio, there shall be submitted to the electors of the Village of Roaming Shores, Ashtabula County, Ohio, the question of a replacing an existing 4.0 mill tax levy and an increase of 1.0 mills to constitute a continuous tax of 5.0 mills for the purpose of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for buildings used directly in the operation of the police department, or the payment of salaries of permanent or part time police, communications or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel in accordance with R.C. 5705.19 (J) of the Ohio Revised Code for a continuous period of years, commencing in tax year 2023 and collected in 2024 and thereafter for each dollar of the taxable property within Village of Roaming Shores, Ashtabula County, Ohio, which proposed replacement levy in taxation, expressed in dollar and cents, for each \$1,000.00 valuation, will amount to \$361,142.00.

SECTION 2. That in accordance with Section 5705.19 (J) and 5705.25 of the Revised Code of


Ohio, the ballot submitted to the electors shall set forth that said levy is a replacement levy of 4.0 Mills and an increase of 1.0 mill to constitute a continuous tax of 5.0 mills beginning tax year 2023 and collected beginning in 2024 for the benefit of the Village of Roaming Shores, Ashtabula County, Ohio, for the purpose of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for buildings used directly in the operation of the police department, or the payment of salaries of permanent or part time police, communications or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel in accordance with R.C. 5705.19 (J) of the Ohio Revised Code.

SECTION 3. That the said question is to be submitted to the electors of the Village of Roaming Shores, Ashtabula County, Ohio, at the general election to be held on November 8, 2022 and that the Election shall be conducted, canvassed and certified in like manner as regular elections in said Village of Roaming Shores, Ohio, for the elections of officials thereof, and shall be submitted in like manner and form provided by Section 5705.25 of the Revised Code of Ohio.

SECTION 4. That the Clerk/Treasurer of the Village of Roaming Shores, Ashtabula County, Ohio, is hereby authorized and directed to certify a copy of this Resolution to the Board of Elections of Ashtabula County, Ohio, and to notify said Board of Elections to cause a Notice of Election on the question of levying said tax to be given as required by law, in order that the Board of Elections may make the necessary arrangements for the submission of a replacement levy of 4.0 mills and an increase of 1.0 mills to constitute a continuous tax of 5.0 mills levy for the police to the electors of the Village of Roaming Shores, as provided by law, at the general election to be held on November 8, 2022. Said notice of Election shall specify the levy as a replacement police levy, the proposed rate to be levied, the time during which said levy is to be in effect and the time and place of holding election.


Section 4. As provided for in section 5705.19 (J) of the Revised Code of Ohio, this resolution shall go into immediate effect upon passage, and no publication of same shall be necessary other than that provided for in the Notice of Election, and that this Resolution shall take effect and be in force from and after the earliest period allowed by law.
